On this form, the term property owner refers to the lessor, property manager or manager/provider who has the authority to act on behalf of the property owner.

When submitting this request by post, the sender must allow time for the mail to arrive when calculating the date the property owner must respond by (item 6).

CONDITIONS FOR APPROVAL

These terms are in addition to the Standard Terms and only form part of this agreement provided they do not conflict with the Act or the Standard Terms and the parties have gareed to the Conditions for Approval.



IN ADDITION TO SPECIAL TERM 3 - PETS

- (2) Where the Lessor has given permission for a pet other than in response to a formal written request from the tenant in the approved form, the tenant agrees at all times to:
 - keep pets outside, unless otherwise stated in writing. This provision does not apply to working dogs.
 - secure, restrain or remove (from the premises) any dogs kept at the premises during routine inspections and, where applicable, entry by a contractor to complete works.
 - (k) repair damage to the premises or inclusions caused by pets, including but not limited to:
 - (i) scratch, claw or chew damage;
 - (ii) urine contamination;
 - (iii) digging or impact damage.
- (6) The tenant will on vacating the premises:
 - (a) arrange for the carpets to be professionally steam cleaned for relevant pets allowed inside the premises, or pets identified as being inside the premises without permission;
 - (b) arrange for the premises to be professionally fumigated (flea & tick) at the end of the tenancy;
 - (c) repair damage to the premises (including the grounds) arising or as a result of the tenant's pets (if any), to the same condition they were in at the start of tenancy;
- (7) **If urine contamination is identified** within the premises, the tenant must (on vacating the premises):
 - (a) Carpeted Areas: remove contaminated carpet and underlay from the premises;
 - (b) arrange for the contaminated areas to be professionally decontaminated and cleaned using an enzyme cleaner;
 - (c) Where applicable, replace carpet and underlay with that of the same or similar quality as the carpet that was removed from the premises.
- (8) The tenant is responsible for full costs incurred to complete repairs or replacements arising or as a result of the tenant's pet, where there is no alternative but to carry out these repairs or replacements and does not provide any benefit or betterment to the premises – Example: carpet & underlay replacement.
- (9) Approval of the pet is subject to by-laws or park rules in managed communities.
- (10) The Tenant shall be liable for any damage, injury or trauma caused by the pet on the premises; whether they are the Tenant's pet or their guests pet and regardless of their approval status.
- (11) The Tenant accepts full responsibility of the pet and indemnifies the Lessor for any claims by or injuries to third parties or their Property caused by, or as result of actions by their pet or their guests' pet, and regardless of their approval status.
